Dear Team Representative:

All adult teams that participate in our Indoor Leagues are required to have the following information on file for each season:

Team Roster Facility Release and Indemnity Agreement

As the Team Rep. you are required to provide/collect this information and turn it in to the League Coordinator or Supervisor on Duty at the front desk prior to the start of your first game each season. All players must be listed on the roster and have a Facility Release before they can participate. Any team that is found to have an unregistered player may forfeit the balance of their games. You may continue to add players to your Team Roster throughout the season as long as they are added to your roster and have a Facility Release on file prior to them participating in a game.

If your team played in the prior season and there are no changes to the roster, you are still required to check in at the front desk and make sure all your information is correct and updated.

All teams must be paid in full prior to the start of the fourth game. As Team Representative, it is your responsibility to see that your team is paid in full.
